RE: Proposed Changes to the Bylaws of the Undergraduate Council (Appendix XIII)

In the spring of 2015, a full vote of the UCLA faculty approved a proposal to institute a mandatory diversity requirement for all undergraduate students in the College of Letters and Science. Prior to this, only the School of Arts and Architecture required undergraduate students to complete a diversity course as a part of their school requirements. Since the approval of the College of Letters and Science diversity requirement proposal, the newly formed Herb Alpert School of Music has instituted a diversity requirement for its undergraduate students. The Luskin School of Public Affairs has a proposal (currently before the Academic Senate) to offer an undergraduate degree, and their proposed degree regulations also include a diversity requirement for undergraduate students.

For the past two years (2015-2017), the Undergraduate Council has appointed an Ad Hoc Diversity Syllabus Review Committee to review courses proposed to satisfy the diversity requirement. This ad hoc committee has worked successfully with the Undergraduate Council, and the Diversity Initiative Steering Committee, which was appointed by the Executive Vice Chancellor. The proposed amendment to Appendix XIII, approved by a unanimous vote of the Council on June 9, 2017, seeks to formalize the status of the Ad Hoc Diversity Syllabus Review Committee as a committee appointed annually by the Administrative Committee of the UgC and to codify the authority that it has exercised in the area of diversity curriculum over the past two years.

The amendment has been drafted to reflect the history of Ad Hoc Diversity Syllabus Review Committee and to preserve its status as a non-standing committee that advises the Undergraduate Council on all matters pertaining to diversity curriculum, while recognizing and valuing its function. The proposed bylaws also incorporate the amendments requested by the Committee on Rules and Jurisdiction in their June 22, 2017 memorandum to the Council.

The Committee on Rules and Jurisdiction has reviewed the revised Bylaws that the Undergraduate Council submitted on June 20, 2017, and, with one exception, finds them consistent with the Code of the Academic Senate.

While Section III.C of the Operating Procedures is generally correct, Title II, Section 12 is not correct as stated. It should be amended to make clear that the non-Senate faculty members and student members do not vote on final actions. This needs to be corrected throughout Appendix XIII, Bylaws of the Undergraduate Council. For example, in all sections where students are listed as members of a subcommittee.

Once corrected, this memo, the approved bylaws, and the former bylaws will be sent to the Executive Committee of the Academic Senate and placed on the Consent Calendar for the next meeting of the Legislative Assembly.

(A) <i>Membership</i> . DIVERSITY EDUCATION GOVERNANCE COMMITTEE OPERATING PROCEDURES

I. Authority

The Diversity Education Governance Committee is a committee of the Undergraduate Council and advises the Undergraduate Council (UgC) and the Vice Provost for Undergraduate Education on all matters pertaining to Diversity Education at UCLA.

II Duties

The Committee is charged by the Undergraduate Council to carry out the following duties:

- A. Defining the values and purposes of diversity education at UCLA.
- B. Providing clear guidelines and procedures for the development of diversity courses.
- C. Reviewing and recommending to the UgC diversity credit for all courses transmitted by the College and professional school Faculty Executive Committees to satisfy diversity requirements.
- D. Reviewing and recommending to the UgC suspension or rescission of diversity credit for courses which are found to no longer align with diversity education principles and practices.
- E. Conducting periodic self-reviews and evaluations of UCLA's diversity education curriculum.
- F. Advising the UgC and members of the administration on the development, implementation, and assessment of programs for faculty development and TA training in the area of diversity studies and diversity in the classroom which may include recommending/developing orientation and training sessions as well as conferences, symposia, and workshops.

III. Membership

- A. Per Appendix XIII Bylaws, Title II: The Diversity Education Governance Committee is appointed yearly by the Undergraduate Council Administrative Committee. It consists of 7 members: a Chair, one member from the Undergraduate Council, and five Senate Faculty members representing the College and the other schools that admit undergraduate students.
- B. The Undergraduate Council member of Diversity Education Governance Committee shall represent the UgC in the committee's deliberations and apprise the Council of all diversity education governance actions pertaining to UCLA's diversity requirement curriculum.
- C. Additionally, the Committee shall have two non-Senate Faculty members. The non-Senate Faculty members shall be granted the privilege of the floor.
- D. Additionally, the Committee shall have one undergraduate student member. The student member shall be granted the privilege of the floor, and their votes shall be counted separately. Student members shall be appointed by the UCLA student governments, with special consideration given to student members already serving on the UgC.

The appointments of the committee Chair and faculty shall be for three years, beginning on September 1st, and can be renewed by the Undergraduate Council Administrative Committee.

V. Meetings

- A. The Committee shall meet at least once a quarter each academic year. The Committee shall also meet at the call of the Chair, or by petition to the Chair of at least 20% of the Committee's membership.
- B. Other instructional officers may be invited to attend Committee meetings and receive the courtesy of the floor.
- C. All meetings of the Committee are governed by procedures specified in Senate Bylaw135D.
- D. One third of the voting members of the Committee constitutes aquorum.
- E. If no quorum is present at a scheduled meeting of the Committee, all matters on the agenda requiring a vote shall be submitted to a mail, e-mail, or an electronic online ballot no later than 10 calendar days after the scheduled date of the meeting.
- F. At the discretion of the Chair, Committee business and votes may be conducted by mail, e-mail, or online.

VI. Committees

A. At the discretion of the Chair, subcommittees and ad hoc committees may be appointed by the chair as needed. Any reports of recommendations made by ad hoc committees and subcommittees must be submitted to the UgC for final consideration and approval.

VII. Amendment of Operating Procedures

The foregoing operating procedures may be added to, amended, or repealed at any regular or special meeting by a simple majority vote of the Committee members present, provided notice shall have been sent to each member at least five days previous to the meeting at which the amendment is to be moved. Amendment of Operating Procedures requires approval of the Undergraduate Council.
